The health and temperament of this dog is excellent to the best of our knowledge and belief at the time of sale. The required vaccinations and anti-helminthic are as indicated on the health record. The purchaser must have the dog examined by a licensed veterinarian within 48 hours of purchase. If the veterinarian finds immediate life-threatening fault(s) with the dog, the dog must be immediately returned to us at the expense of Purchaser. A replacement canine of equal value, unless other arrangements are mutually agreed upon, will be provided. Failure to see a veterinarian within 48 hours will void the replacement guarantee.

Our dogs are guaranteed for 36 months against crippling hip/elbow dysplasia confirmed by x-rays from a board-certified veterinary radiologist. The images and report from the veterinary radiologist must be provided for review. Should the Purchaser retain the said dog, the Purchaser thereby forfeits any replacement. The dog is to be returned to us at the expense of the purchaser. This is a replacement guarantee only, with a dog/puppy of equal value. The replacement will be done as soon as possible.

As purchaser, I agree to feed a premium Dog Food and provide adequate water (at least 61 ml / kg of body weight per day). I agree to provide superior healthcare. Superior care includes routine heartworm preventatives, dental preventatives, deworming, flea and tick preventatives, yearly blood chemistry, yearly complete blood count, yearly urinalysis and yearly heartworm test. I agree to provide adequate shelter from the elements (wind, rain, hail, heat, etc.).

If I am unable to provide optimal care or can no longer keep the animal I agree to give **Working K9 training research and training center (dba Southeast K9)** first option to take the puppy/dog back.

I agree to give the puppy / dog back if the pet is mistreated physical, mentally or not provided optimal care.

This puppy / dog is sold as pet quality. The puppy / dog is sold with limited registration. Registration may be upgraded to full with prior written approval from **Working K9 training research and training center (dba Southeast K9)**.

Sales are final, and down-payments are non-refundable. I understand this is a replacement guarantee with a puppy / dog of equal value at the time of purchase.
